Kucetyiswa ukuba uye egqwetheni xa ubhala ngendlela ehlunelile labhala ngayo ilifa, lize kuncoryshwa nokuba igqwetha lakho linyulwe kubhale igama lalo lothile lakho lize lize nambopheleleko yempahla yakho.

Kuzo kwenzeka ntoni kwiingqinamba ezibandakanyekileyo ezibandakanyekileyo?

Eyona ndlela yokugqibela ukuba emva kokuba uvulekile izinto onazo zibhale isakhelo ngokunwabela naminqwano yakho nangokwendlela eyolele ngayo, kubhale phantl ukuba zifanele zizifone bend. Olu kulandela ilifa lakho ubhale ukhetha Umntu oza kubhale igama lakho phantl oza kowaba izinto onazo. Ukuba uvuleka ukagqibela ubhale phantl indlela ilifa ehlunelile labhala ngayo, inxaxhepo yakho lize kuba sengqinamba yaye kuba nziyo kuyo.

Xa umntu osweloka engqinamba abhale phantl indlela ehlunelile labhala ngayo ilifa, Impahla lya kudlulelwa ngokwendlela ofuna ngayo i-Intestate Succession Act. Kufuneka ezinjalo, Impahla lya kudlulelwa kwiqabano lomthetho eliseleyo okanye kwiqabano lomthetho nakubantwana balowo uvulekileyo nakubantwana abaswelekileyo (okanye kuzakuba bono abaswelekileyo, uye kuzakuba kubazali yaye emva kokuba bono abaswelekileyo, lize kufuneka ngabantu abaswelekileyo nodadewabo).

Iqela yabantu njani Impahla yomntu abaswelekileyo?

Xa umntu osweloka ehlala izinto onazo okanye abhale phantl indlela ehlunelile labhala ngayo ilifa, iqabano lomthetho eliseleyo — okanye ukuba akukho iqabano liseleyo isakuzona

okukhethwa esihlala kakhulu akaswelelwa kuzo — Ilifelo zingaphelanga linqaku esili-14 ukusuka kusuka akaswelelwa ngalo ndlela ingqale esilo naphila ngendlela emibheyo ku lilemuli Wankanda Ephakamileyo.

Emva kokuba kudlulelwa ingqale ngempahla, uMlawuli unyula Umntu okubhale igama lakho phantl oza kowaba ilifa ngokubhala lize Yakwabona Kwezinto (ukuba izinto zomntu oswelokileyo zibhale ngaphakathi kwan-R125 000) okanye ILeta Egunyazwayo (ukuba izinto zomntu oswelokileyo zibhale ngaphantl kwan-R125 000).

Igqwetha lakho lizubhale kokuncada ulungiselele amawebhu angqale okanye kwanokutha xa kubhale impahla.

Iqabani emawebhu aze abhale phantl njengokwazi ilifa?

Kucetyiswa ukuba kufunelwe kunyulwa igqwetha lakho njengomntu oza kubhale phantl ukuba abe ilifa kuba lona

- Iqhelana nani iqaliso elowile lakho,
- Iyazazi izinto onazo ukuba ziphi,
- Incediso elizaziyo ngemibhalo yentlalo yakho,
- Inzulungelo kokudlulelwa ngqinamba na Impahla ngendlela ekulindlelele ngayo, lize
- Inehwazi okufunekileyo okungokwasemthethweni ngendlela ezinokwazi ngayo izinto.

Noko ke, lungu lizaziyo ngqinamba lakho bamokonyulwa aze amaqanda abo abhale phantl njengabazali kowaba ilifa.

Impahla yomntu oswelekileyo okanye inxalenye yempahla ukuba liza kuyigcina kakuhle. Iindlelifa zinelungelo lokungena Kwisivumelwano Esitsha Sokudluliselwa Kwezinto yaye eso sivumelwano simela sidluliselwa kuMlawuli oza kwamkela eso sivumelwano. Kudla ngokufuneka icebo elikhethekileyo legqwetha kwiimeko ezinjalo.

Yintoni enye into umntu afanele ayazi ukuze abe nantambo kakhulu kwindlela owabhiwa ngayo impahla?

Umntu obhalwe phantsi ukuze abe ilifa, mhlawumbi ngaphambi kokuba le ngxelo ihlolwe ngemvume yoMlawuli unokukhupha imali eyaneleyo nempahla ethile njengombono yaloo mntu ubhalwe phantsi njengombi ukuze intsapho yomntu oswelekileyo ilale ityile.

Ukongezelela, apho ilifa liyimali eyaneleyo yokuhlawula amatyala Umntu obhalwe phantsi ukuze abe ilifa unokughubeka namalungiselelo aye kwiindlelifa bathethe ngelifa nangezinto zomntu oswelekileyo. Le yimeko ekhethekileyo apho umntu eziwele kuye izinto zomntu oswelekileyo iba iqabane lomtshato eliseleyo okanye apho kusenokubakho ukulibaziseka kwezinto.

Yintoni eyenzekayo kwingxelo zempahla?

Ngokuhlawuleza nje emva kokuba kunikelwe ingxelo ngempahla, umntu obhalwe phantsi ukuze abe ilifa ubala ixabiso lezinto nelamatyala ukususela ngemini umntu asweleka ngayo.

Emva kokuba kufunyenwe ileta Yokwabiwa Kwezinto Umntu obhalwe phantsi ukuze abe ilifa umele apapashe isaziso kwiGovernment Gazette nakwamanye amaphephandaba akwisithili lo uswelekileyo ebohlala kuso kubizwa bonke abantu abayibangayo Impahla baze bakudlulisele oko Kumntu obhalwe phantsi ukuze abe ilifa kungaphelanga beshia elithile elimisiweyo, ngokughelekileyo elidla ngokuba ziintsuku ezingama-30 ukususela kusuku lokugqibela ekupapashwe ngalo.

Emva koko, kodwa zingaphelanga linyanga ezi-6 emva kokuba ileta Yokwabiwa Kwezinto ifunyenwe, okanye ngelinye beshia njengokuba uMlawuli esenokuvuma, Umntu obhalwe phantsi ukuze abe ilifa unembopheleleko yokudlulisela kuMlawuli ingxelo yokuba kubhangiswe oko nokwabiwa kwempahla.

UMlawuli uya kuyihlolisa le ngxelo aze ukuba ifanelekile, anike igunya Umntu obhalwe phantsi ukuze abe ilifa

abhangise le ngxelo ukuze ihlolwe. Le ngxelo yoMntu obhalwe phantsi ukuze abe ilifa imele ihlale ivuliwe kwiOfisi yoMlawuli – ibe ukuba lo mntu uswelekileyo ibingumntu owaziwayo kuso nasiphi na isithili, ikopi yale ngxelo ifanele ihlale ivuliwe kwiOfisi kaMartyr – kungekhona ngaphantsi kweentsuku ezingama-21, ukuze ihlolwe ngomnye umntu onomdla kule mpahla. Umntu obhalwe phantsi ukuze abe ilifa umele apapashe isaziso kwiGovernment Gazette nakwamanye amaphephandaba akwisithili aziwa kuso lo mntu uswelekileyo, esi saziyo sichaze beshia nendawo eza kuhlolwa kuyo le ngxelo.

Emva kokuba beshia lokuhlola lidlulile, uMlawuli uya kwazisa Umntu obhalwe phantsi ukuze abe ilifa ukuba ingxelo lindelwe ukuhlolwa kungekho kuxambulisana. Umntu obhalwe phantsi ukuze abe ilifa unokuhlawula abantu ababolekisa ngemali aze abe impahla kwiindlelifa ngokuvumelana nale ngxelo. Umntu obhalwe phantsi ukuze abe ilifa uya kudlulisela kuMlawuli irisithi zabantu ababolekisa ngemali nakwiindlelifa.

Ukuba Umntu obhalwe phantsi ukuze abe ilifa unemali ezi-R1 000 okanye ngaphezulu, uya kuvula iakhawunti yebhanki. Noko ke, oku kuvumeleka apho igqwetha liza kusebenzisa iakhawunti layo ukuze lifake imali zalawo uswelekileyo.

Irhafu Yexabiso Elogaziweyo, Irhafu Yeenzuzo Zenkunzi neRhafu Yengeniso Umntu obhalwe phantsi ukuze abe ilifa uya kugqibela enoba impahla unokuhlawula irhafu yengeniso (VAT).

Ukuba umntu oswelekileyo ubhaliswe njengomntu obethengisa Umntu obhalwe phantsi ukuze abe ilifa unokubhalisa impahla ukuze kutsalwe IVAT.

Kuza kutsalwa IVAT. Umntu obhalwe phantsi ukuze abe ilifa kusenokufuneka ahlawule irhafu yokukhutshwa kwazo zonke izinto zomntu oswelekileyo kwiSouth African Revenue Service. Umntu obhalwe phantsi ukuze abe ilifa usenokukwazi ukuthengisa ezi zinto komnye umntu othengisayo ohlawula kuze kungabikho nto kwiakhawunti.

I-Income Tax Act iyakwenza oko xa umntu esweleka, loo mntu zisenokuthathwa zonke izinto zakhe ngenxa yemali efunyenweyo xa bekuthengiswa ezo zinto okanye kongezeleleko ezinye izinto azilingana nezo ngerxa yexabiso lezo zinto yaye impahla yalo mntu uswelekileyo isenokungaboni ixabiso lezo zinto. Lo ngumthetho oqhelekileyo, kodwa izinto zenziwa ngendlela eyahlukileyo kwabanye abantu. Ngokomzekelo, izinto eziwele kwiqabane

lomtshato eliseleyo emva kokuba kuqale kwafa elinye kuwo ziyafumaneka.

Kwimpahla ezininzi irhafu yengoniso iyahlawulwa. Oku kusenokuchaphazela kubungakanani bemali eza kufunyanwa ziindlelifa.

Umsebenzi wempahla ubhalulwa nini?

Lo msebenzi uhlawulwa imali esisigxina angangama-20 ekhulwini. Ubalwa ngokuthatyathwa kwezigidi azizi-R3.5 'kwixabiso jemali esalayo'. Babiso lazo zonke izakhiwo liqokwe kwimpahla yomntu oswelekileyo yaye ilwela kwiqabane lomtshato eliseleyo, ngokuvumelana nelifa lomntu oswelekileyo okanye ngokuvumelana nomthetho lisenokutsalwa ukusa kwinqanaba lokuba liqokwe kwimpahla.

Ngaba indlelifa inokuzikhethele?

Nawuphi na umntu oza kufumana kweli lifa unelungelo lokulala nelifa.

Ukhethe lubakho xa amaqabane omtshato eye alinika abantu abaninzi impahla zabo yaye iqabane lomtshato eliseleyo alilifuni ilifa okanye lingasifuni isabelo salo linandiphe nje inzuzo zalifa. Olu khetho lwenziwa liqabane lomtshato eliseleyo kuthiwa 'yi-adiation'.

Xa umntu obefanele ukuba ufumane ilifa engalifuni, elo lifa liya kwabiwa ngokuvumelana nomnqweno womntu oswelekileyo okanye ngokuvumelana nendlela umthetho ofuna ngayo.
